Action Plan following the 6th EASO Consultative Forum

1. Background/context: EASO Cooperation with civil society

In line with Art. 51 of the EASO Founding Regulation, EASO is committed to maintain a close dialogue with civil society organisations (CSOs) with a view to enhancing mutually beneficial synergies. Many different organisations operate in the field of asylum and their respective expertise, experience and insight is of much added-value to the Agency's work. The Consultative Forum was set up as a mechanism to enhance the exchange and sharing of knowledge between EASO and relevant stakeholders from civil society.

EASO recalls that cooperation with CSOs takes place on a regular basis throughout the year in various different forms, e.g. multilateral and bilateral information exchanges, thematic (information) meetings¹, open consultations on key EASO reports, targeted consultations with specialised CSOs through their participation in EASO expert meetings, seminars, workshops, involvement in the development of EASO training material, EASO Practical Tools etc. A plenary meeting is organised on an annual basis.

2. The 6th plenary EASO Consultative Forum Meeting

In 2016, the plenary meeting was held on 28^{th} and 29^{th} November in Athens, attracting a record number of over 200 participants.²

The plenary meeting served multiple aims. By bringing together many different types of stakeholders active in the field of asylum, it served to identify and strengthen synergies as well as to promote multi and cross-dimensional information flows (from institutional level to civil society and vice-versa as well as across civil society representatives). Moreover, the Consultative Forum also specifically aimed to:

- Take stock of relevant developments in the field of asylum in 2016 (e.g. relocation/hotspots, legislative proposals tabled by the Commission for the reform of the CEAS);
- Identify constraints and challenges in the development of the CEAS;
- Seek solutions to constraints and challenges, in particular by providing relevant suggestions for action by EASO within the remit of its mandate.

3. Aims and rationale of the Follow-up Action Plan to the 6th Consultative Forum Meeting

This Action Plan answers to the latter aim and sets out specific actions to be implemented by EASO as identified by participants during the Forum. The codification of these actions in this plan reinforces EASO's commitment to implement these, ensuring appropriate follow-up to the Consultative Forum with a view to increase transparency and accountability.

4. Development and selection of action points

The specific actions stipulated in this plan were identified on the basis of all contributions made during the Forum, in particular on the results of:

- The participatory workshops (agenda point 3 of the Consultative Forum);
- The open agenda session (agenda point 4 of the Consultative Forum during which participants discussed topics related to the CEAS, which they prioritized).

Main topics discussed during these sessions included, a.o., relocation and the hotspot approach, intra-EU solidarity, the provision of information, analysis and communication, training, country of origin information (COI), vulnerable persons (including gender, cultural awareness, mental health needs etc.), the external dimension, EASO's expanded role and competencies under the EUAA, including a possible revised structure for the Consultative Forum etc. Such topics were discussed from all different angles with suggestions for action made to different actors (e.g. the Commission, EASO, Member States including local authorities).

A complete overview of suggestions for action is included in the Annex to the 6th EASO Consultative Forum report. As explained, however, by EASO's Executive Director during the Forum, "not all input, proposals and ideas can be translated into action by EASO; only those that are within EASO's mandate and which are feasible within the strict boundaries of EASO's rules and procedures". The selection of actions involved a careful review of whether i) EASO was designated as actor to implement the action; ii) EASO was best placed to implement the action; iii) the action falls within EASOs mandate (in line with the EASO Regulation, its mission, competencies and tasks); iv) the action would have sufficient impact on EASOs overall objectives; v) the action was considered feasible to implement in practice (in terms of human/financial resources); vi) there was internal commitment for its implementation.

Following internal consultation, EASO has prioritised several concrete, targeted and feasible actions.

5. Action points

The table on the next page provides an overview of the actions to be implemented. The table is structured according to overall objectives of the actions, theme/type of EASO activities and indicates also the specific department/unit responsible within EASO for the implementation of the action. The last column lists indicators that can be used for the monitoring of the implementation of the actions. A monitoring report on the implementation of the Action is scheduled for November 2017.

Overall, the actions selected address the following main objectives:

- Reinforce CSOs engagement across various different EASO activities (e.g. COI, information & analysis, operations, external dimension, training, practical tools, courts and tribunals, vulnerable groups etc.);
- Strengthen EASO's feedback system to CSOs;
- Improve communication on migration by better utilising different methods;
- Strengthen Member States' capacity to attend to the needs of vulnerable persons by better promoting EASO tools and practical guidelines;
- Further strengthen the quality of asylum processes by stepping up training on intercultural communication
