The report will be finalised by collecting information from EU+countries, civil-society stakeholders, UNHCR and other relevant sources on main developments in asylum policies and practices of EU+ countries in 2016.

We would kindly like to ask you to provide your <u>observations</u>, - preferably bullet points to facilitate further processing of your input - on developments in asylum law or practice in 2016 (and early 2017) in the areas listed below, reflecting the usual structure of the report. Observations may concern national practices of specific EU+ countries or the EU as a whole.

The EASO Annual Report will not describe the national asylum systems in detail but present key developments in 2016, including <u>improvements and new/remaining concerns</u>. The topics listed below reflect the structure of chapter 4 of the EASO report on the 'Functioning of the CEAS'. We kindly ask all contributors to provide brief summaries only on those topics/issues that have seen important <u>improvements/deterioration as well as new concerns or where previous relevant concerns remained in 2016</u>.

Please bear in mind that the EASO Annual Report is a public document. Therefore, your input should be, whenever possible, supported with references to written sources to ensure transparency. That can be done by providing links to any documents such as position papers, important press releases, studies, comments, input to the other reports, public statements to government programs, etc.

While EASO endeavours to cover all relevant developments and strives to include as many references as possible, the final content of the EASO Annual Report remains bound by its terms of reference and volume. Therefore, while all contributions are gratefully received and recognised, EASO may edit contributions for length and clarity and use the submissions to best serve the objective of the Annual Report: to improve the quality, consistency and effectiveness of the CEAS.

EASO COI commentaries

Asylum Research Consultancy (ARC) together with the Dutch Council for Refugees (DCR) continued to publish public commentaries in response to the publication of EASO's COI reports. The following were issued on EASO's COI products published in 2016:

- April 2016: Comments on the EASO Country of Origin Information Reports Afghanistan (January 2016) and Somalia (February 2016). This commentary sets out our main observations, concerns and recommendations based on an initial reading of the reports, focusing on Chapter 2.1.1 'Kabul City' for the Afghanistan report and Section 2.7 'Benadir-Mogadishu' for the Somalia report.
- October 2016: Comments on the EASO Country of Origin Information Reports: Pakistan: Security Situation (July 2016) and Afghanistan: Recruitment by armed groups (September 2016). This commentary sets out our main observations, concerns and recommendations based on an initial reading of the reports, focusing specifically on Chapters 1.4 'State ability to secure law and order', 2.2 'Khyber Pakhtunkhwa', 2.4 'Sindh' and 2.6 'Islamabad Capital Territory' for the Pakistan report.
- January 2017: <u>Comments on the EASO Country of Origin Information Report on Turkey (November 2016)</u>. This commentary sets out our main observations, concerns and recommendations based on an initial reading of the report, focusing specifically on chapter '6. The attempted military coup'.

COI Forum

In 2014 Asylum Research Consultancy (ARC) and the Dutch Council for Refugees (DCR) set-up the 'COI Forum'.

It is a free online tool for all COI researchers and users of COI working in refugee status determination to share publications and ideas on COI research and sources, as well as to develop shared resources. The COI Forum is open to such organisations and individuals, subject to approval by the COI Forum moderators, but is a confidential private discussion group only for the use of its members. It is moderated by ARC and the DCR and part of the ecoi.net community forum.

UK Independent Chief Inspector of Borders and Immigration

- In February 2016 the UK Independent Chief Inspector of Borders and Immigration issued its findings following an inspection of asylum casework conducted between March – July 2015. The full report can be accessed here.
- In May 2016 the UK Independent Chief Inspector of Borders and Immigration issued its inspection report on the reviews carried out by the Independent Advisory Group on Country Information (IAGCI), notably on Iran, Nigeria and Ukraine, including some general findings on the working practices of the IAGCI and the Home Office's Country Policy and Information Team (CPIT). UK Home Office's Country Policy and Information Notes (CPINs)

Following the promulgation of MST and Others (national service – risk categories) Eritrea CG [2016] UKUT 00443 (IAC) in December 2016, in which the UK Upper Tribunal of the Immigration and Asylum Chamber expressed its "hope that consideration will be given to terminology that maintains a proper demarcation of the role of the executive and judiciary in the area of evaluation of country conditions and risk in the field of international protection" (para. 9), the UK Home Office's 'Country Information and Guidance' reports were renamed to 'Country Policy and Information Notes'.
