

## **IPA II project “Regional Support to protection-Sensitive Migration Management in the Western Balkans and Turkey” (2016-2019) - Phase I**



- **Geographical coverage:** Western Balkans (WB) i.e. Albania, Bosnia and Herzegovina, Kosovo\*, North Macedonia, Montenegro and Serbia. **NB Turkey** participates only in regional activities.
- **Duration of the project:** 3,5 years, 1 January 2016 – 30 June 2019.
- **Total budget:** 8.25M EUR from IPA/EC instrument (**EASO approx. 1.3 MEUR**). 2 contracts (Frontex leads contract 1, IOM leads contract 2).  
*EASO's own budget is also mobilised to carry out complementary activities that went beyond the scope or duration of the project.*
- **Overall objective:** develop a comprehensive and protection-sensitive migration management system in the Western Balkans and Turkey.
- **Specific objective:** improve the capacity of the national authorities to offer a protection-sensitive response to mixed migration flows by strengthening identification mechanism, registration, improving systematic information exchange and

preparing sustainable return solutions.

- **Indirect objective:** Support to the EU accession (chapter 24 negotiations where applicable).
- **EASO has a key role in implementing activities within contract 1:**
  - **Intervention 1.** Strengthening identification mechanism regarding irregular migrants and asylum seekers including screening on nationality (*strong involvement of EASO*).
  - **Intervention 2.** Enhancing the capacity and tools of IPA II beneficiaries in the WB to perform the registration of mixed migration flows in a harmonised manner, observing future interoperability with EU/Schengen MS systems and practices, and in full respect of fundamental rights (*no specific role for EASO*).
  - **Intervention 3.** Setting up referral system into national mechanisms (*lead by EASO*).
  - **Intervention 4.** Support in establishing EU compatible systems for persons in need of international protection (*lead by EASO*).
  - **Intervention 5.** Establishing appropriate non-voluntary return mechanism at regional level and operational cooperation with the selected countries of origin (*no specific role for EASO*).
