



# Overview of query systems on migration and asylum

## What is a query system?

A query system is a tool used to collect information on a specific topic in a short timeframe. Registered experts in national authorities can launch a query on national policies, practices, legislation and statistical trends and receive replies quickly to address immediate information needs. The comparative overview of the situation in other countries can serve as a point of reference and the information can be used to revise policies, practices and legislation.

There are four different query systems on migration and asylum which are managed by the European Union Agency for Asylum (EUAA), European Migration Network (EMN), General Directors' Immigration Services Conference (GDISC) and Intergovernmental Consultations on Migration, Asylum and Refugees (IGC).



## Key stakeholders

- The **European Union Agency for Asylum (EUAA)** is an EU agency, established in 2011, to assist Member States in the implementation of the Common European Asylum System. As a centre of expertise on asylum, the EUAA provides technical and operational support and training to countries with the aim of establishing a harmonised system in line with EU obligations.
- The **European Migration Network (EMN)** is an EU network of migration and asylum experts, established in 2008, who work together to gather objective, policy-relevant, comparable and up-to-date information and knowledge on emerging issues relating to asylum and migration in Europe. EMN produces reports, studies and policy briefs analysing the development and implementation of policies and legislation. The EMN is coordinated by the European Commission, with the assistance of service providers.
- The **General Directors' Immigration Services Conference (GDISC)** is an informal network established in 2004 to facilitate practical cooperation in the field of asylum and migration between the immigration services of 34 members. The various forms of cooperation include exchanging experiences, developing best practices and informal meetings between the General Directors. External stakeholders, such as the EUAA or IGC, are regularly invited to participate.
- The **Intergovernmental Consultations on Migration, Asylum and Refugees (IGC)** is an informal, non-decision-making forum for intergovernmental information exchange and policy debate on issues of relevance to the management of international migratory flows. Created in 1985, the IGC currently brings together 18 Participating States, the United Nations High Commissioner for Refugees, the International Organization for Migration and the EU.



## The scope of the query systems

The four different query systems have a clearly-defined scope, as seen in the table. Experts in national administrations can choose the forum which addresses the topic of the query. To avoid a duplication of efforts and responder burden, the EUAA, EMN, GDISC and IGC first verify if the information already exists in one of the databases. .
