

The EUAA judicial workshops are based on the corresponding topic covered by the EUAA Judicial Publications. For a full overview, please consult the catalogue of [judicial workshops](#). The workshops are delivered in English by two judicial trainers from different EU+ Member States and comprise of short presentations on the topic, case studies, group discussions and exchanges on relevant case law and best practises.

The EUAA judicial workshops last for 2 full days and normally take place at the EUAA Headquarters in Malta. Exceptionally judicial workshops take place in other Member States. The EUAA reserves the right to revert to the delivery of these workshops online, should the face-to-face organisation be not feasible due to adverse developments around the health situation or any other unforeseeable circumstances.

The workshops are designed for an attendance of around 20 participants, 25 being the maximum. Nominees will be informed of the selection results within the deadline set below. No travel arrangements should be made until a formal invitation has been issued. In most cases, the EUAA will contribute to the travel costs and provide for a daily subsistence allowance.
