## EUAA Training highlights 2022

In January 2022, the European Union Agency for Asylum was launched. The transformation from a support office (EASO) into a fully-fledged European agency includes a reinforced mandate for training which plays an integral part in reaching the objectives of the agency as it underpins the harmonisation of practices across Member States according to legislation and with respect to fundamental rights.

Soon after the launch of the agency, our preparedness to cope with the unexpected was tested to the full. Following the Russian invasion of Ukraine in February 2022, EU+ countries were called to find quick and comprehensive protection solutions for approximately 8 million people fleeing the war. The Temporary Protection Directive provided the framework for a systemic solution. However, although the directive had been in existence since 2004, it had never been activated before. Within a very short timeframe, targeted training on its implementation was developed, and sessions were rolled out enabling Member States to support displaced Ukrainians in a uniform manner.

**This short report provides an overview of how EUAA training addressed immediate needs while building the capacities of national asylum and reception systems through the provision of training.**



# Key Figures

All training activities delivered through permanent support and operational support

EU Member States have a shared responsibility to welcome asylum seekers in a dignified manner, ensuring that they are treated fairly and according to uniform standards. This entails harmonising practices so that a person seeking international protection will go through a similar procedure regardless of which Member State is assessing their application.

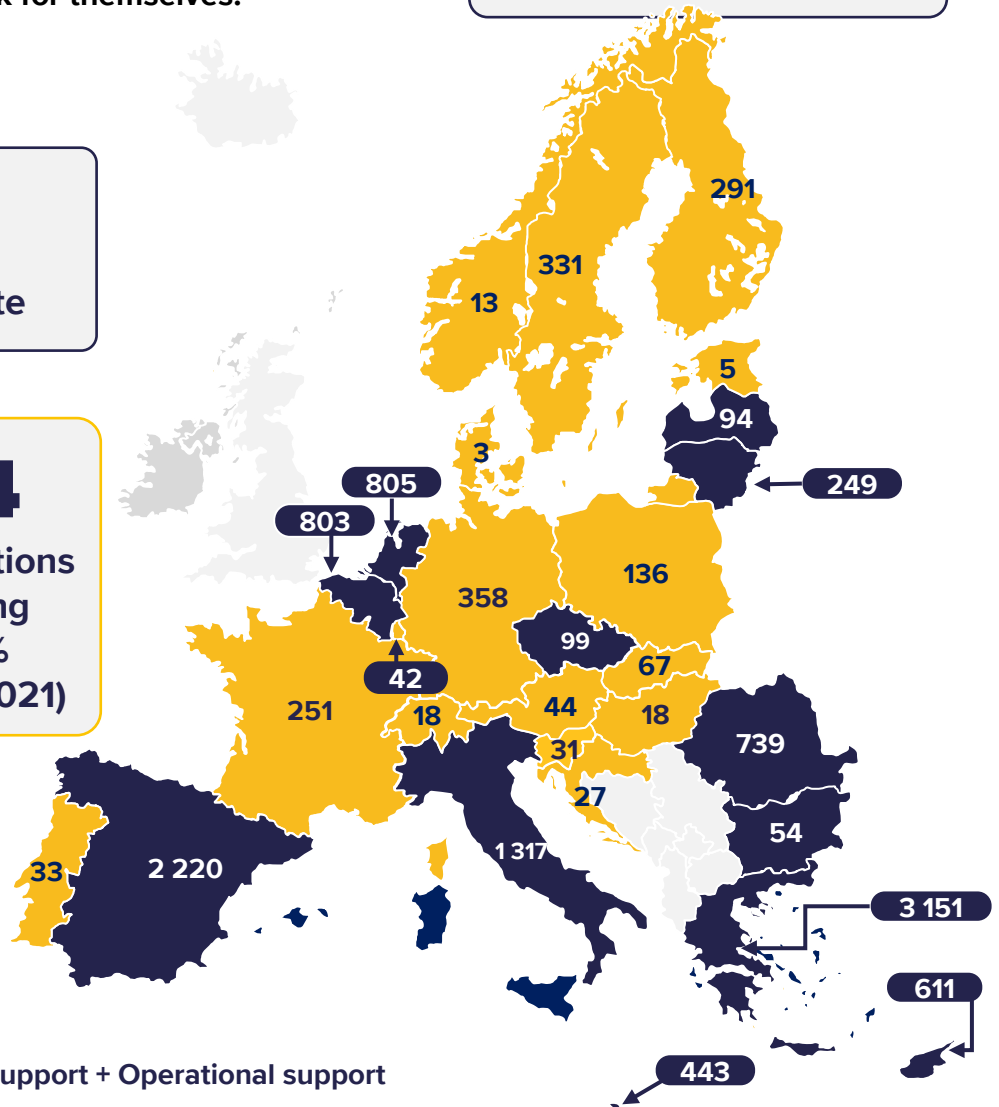

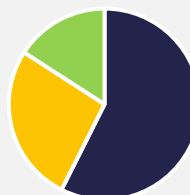

Throughout 2022, increasing numbers of people sought asylum in the EU and over 4 million Ukrainians registered for temporary protection. By the end of the year, half of EU countries had requested operational support.

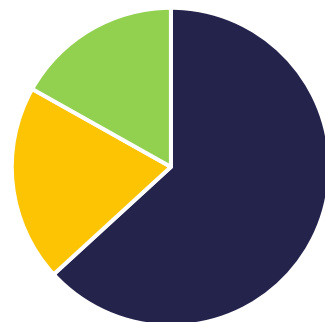

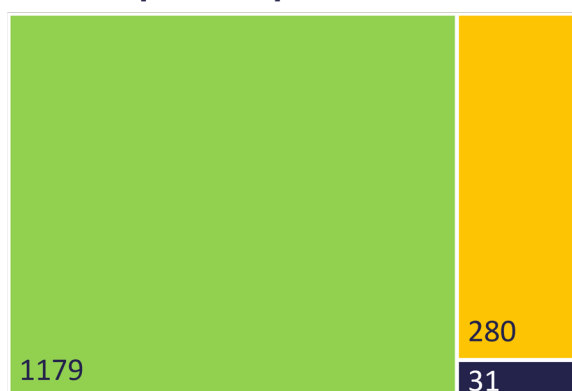


The training included sessions on the implementation of the Temporary Protection Directive as well as communication and information provision. Particular focus was placed on communicating with persons who had experienced traumatic events and with children.

The offer was complemented by existing European Asylum Curriculum modules such as the foundation modules or the module on Trafficking in Human Beings.

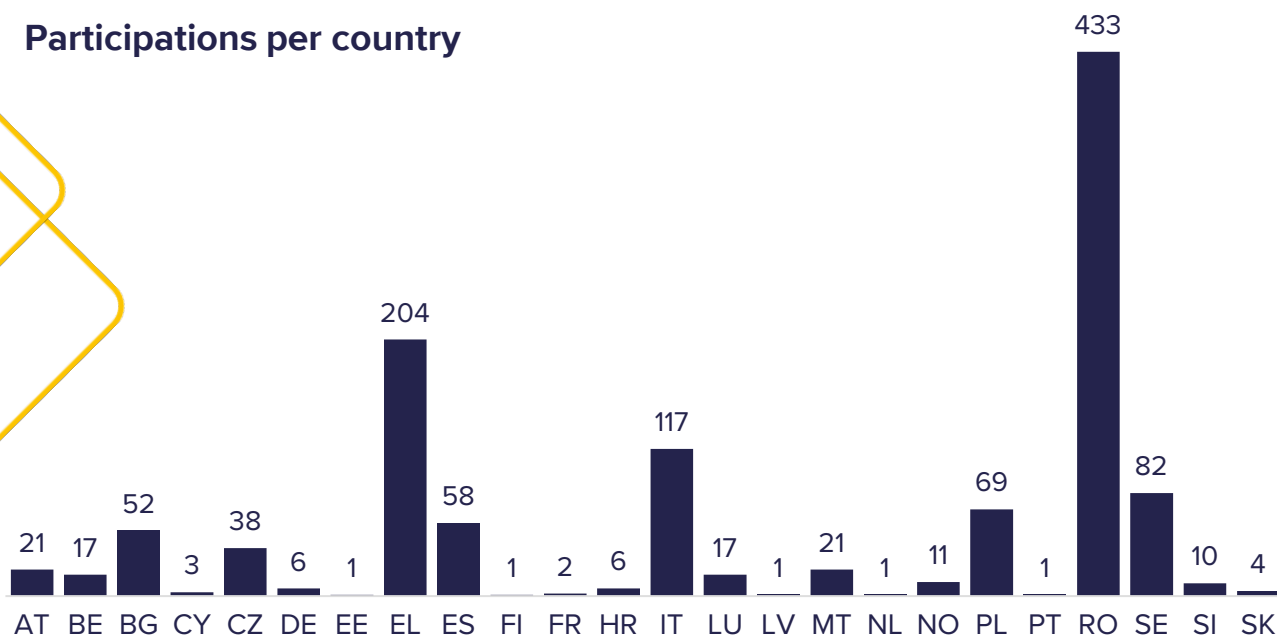

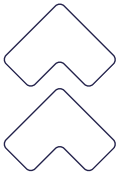

Trainers can also follow modules from the dedicated path for trainers.

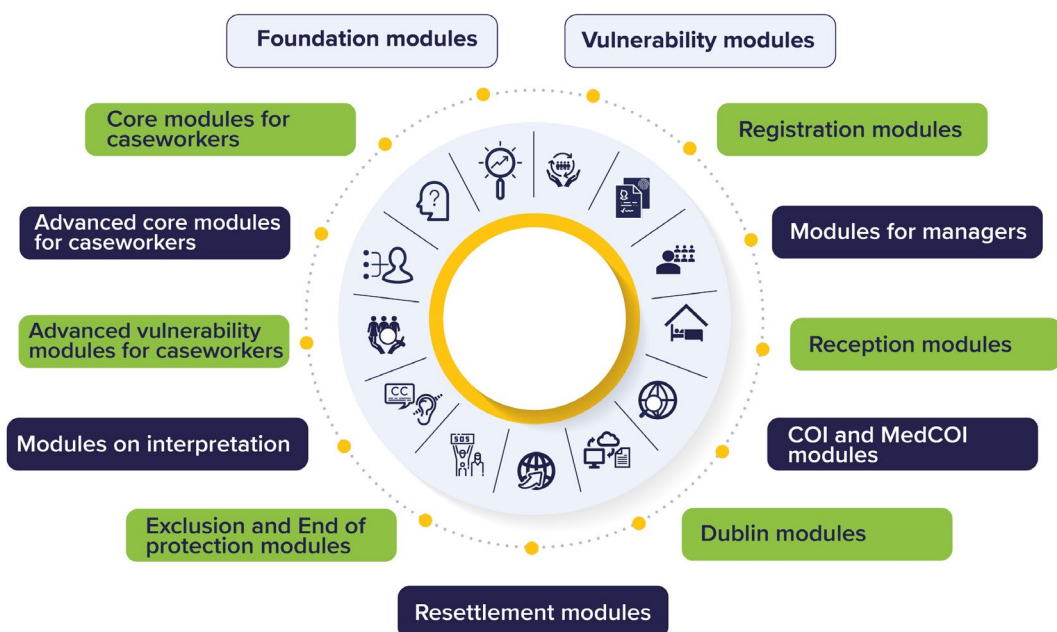
