# Procedure reference number EUAA/2022/095 – Concession Contract for the Provision of vending machines for EUAA in Malta

#### **EX ANTE PUBLICITY**

#### I. Description of the services/supplies

The European Union Agency for Asylum (EUAA) is planning to place on site fully automated floor standing vending machines to be installed at the EUAA premises situated in MTC, Winemakers Wharf, Grand Harbour Valletta, MRS 1917, Malta.

More in detail, the requested services/supplies will include:

The initial installation of:

- 6 food and drinks vending machines
- 1 cold drinks vending machine
- 1 food vending machine

Additional machines will be requested as required when/if needed.

EUAA might also request vending machines to be placed at additional premises, within the Maltese Islands, whether rented or owned by the EUAA or where EUAA staff are assigned or deployed.

## II. Description of the contract

EUAA envisages awarding a concession contract. The duration of the contract will be 12 months renewable up to 3 times for a total duration of 48 months The estimated total turnover of the concessionaire generated over the full duration of the contract is € 130.000,00 without VAT.

### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators' trough which EUAA may award the above-mentioned contract.<sup>1</sup>
