## **Ex-ante publicity**

# **EUAA/2022/081** – Negotiated procedure for Provision of Internet Connectivity services for **EUAA** in Cyprus

### I. Description of the supplies

The European Union Agency for Asylum (the **EUAA**) is planning to purchase services for Internet connectivity in EUAA Cyprus. More in detail, the requested services/supplies will include:

- Provision of the internet lines in:
  - p/a Pournara First Reception Centre for Applicants for International, Protection, 2660 Kokkinotrimithia, Nicosia District, Cyprus (2 internet lines) 24/7 Internet with minimum speed 100/20 Mbps and 1 static IP;
  - Office building CH97-10 Strovolos, Avenue, 2011 Strovolos, Nicosia, Cyprus with 24/7
    Internet with minimum 200/100 Mbps and 1 static IP;
  - Asylum Service Ministry of Interior, 70, Arch. Makariou III avenue, Afemia House, 5th floor, 1077 Nicosia, Cyprus 24/7 Internet with minimum speed 100/20Mbps and 1 static IP;

#### II. Description of the contract

The EUAA envisages awarding a single framework contract with the maximum estimated duration of **48 months**. The estimated total value for the whole framework contract duration is **€ 30,000.00**.

#### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least **3** economic operators through which the EUAA may award the above-mentioned contract.<sup>1</sup>

This ex-ante publicity has an indicative value and is in no way binding on the EUAA. The EUAA may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.
