# **Ex-ante publicity**

## **EUAA/2023/174 – Single Framework Service Contract**

## Negotiated procedure for Provision of Printing Services for EUAA in Greece

#### I. Description of the services/supplies

The European Union Agency for Asylum (the EUAA) is planning to purchase digital printing services for EUAA in Greece.

More in detail, the requested services/supplies will include:

Provision of Printing Services for EUAA premises, offices, containers, and hubs in Greece. The
contract will cover printing services in locations covered by the EUAA operation plan throughout
Greece (e.g. Athens, Thessaloniki, Lesvos, Chios, Samos, Kos, Leros), including any refugee camps.

#### II. Description of the contract

The EUAA envisages awarding a service single framework contract. The maximum estimated duration of the contract will be 48 months. The estimated total value for the whole framework contract duration is €40.000.00.

# III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 3 economic operators through which the EUAA may award the above-mentioned contract.<sup>1</sup>

This ex-ante publicity has an indicative value and is in no way binding on the EUAA. The EUAA may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.
