**Procedure reference number EASO/2021/914 - Framework Supply Contract for the Provision of fuel and car washing services for EASO in Spain – re-launch**

**EX ANTE PUBLICITY**

**I. Description of the services**

The European Asylum Support Office (EASO) is planning to purchase fuel and car washing services for EASO in Italy, with the aim to facilitate the 24/7/365 mobility of EASO staff and deployed persons travelling on the territory of Italy, by ensuring supply of fuel, facilitated through the use of fuel cards, by a reliable and reputable fuel provider.

More in detail, the requested supplies/ services will include:

**1. Fuel:**

- Euro Diesel, quality conforming to the standard EN 590:2009 or equivalent
- Euro Super/ Unleaded (95 octane), quality conforming to the standard EN 228:2008 or equivalent

**2. Fuel cards and devices:**

The fuel cards or devices shall facilitate the supply of fuel and car washing services, with no cash payment involved.

The expected number of fuel cards to be provided is 3 (mainland and islands).

**3. Car washing services:**

- Exterior car wash
- Combined exterior car wash and interior cleaning
- Interior Valet (Valleting)
- Engine Cleaning

**II. Description of the contract**

EASO envisages awarding a single Framework Supply Contract. The maximum estimated duration of the contract will be **48 months**, including all renewals. The estimated total value for the whole framework contract duration is **€ 35,000.00**.

### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 3 economic operators through which EASO may award the above-mentioned contract.<sup>1</sup>

This ex-ante publicity has an indicative value and is in no way binding on EASO. EASO may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.
