Procedure reference number EASO/2020/828 – Framework Service Contract for the Provision of Security Trainings and Security Consultancy – re-launch of the procedure

## **EX ANTE PUBLICITY**

## I. Description of the services

The European Asylum Support Office (EASO) is planning to procure **Security Trainings and Security Consultancy** services with the aim to provide security and safety awareness as well as emergency response knowledge to EASO staff in EASO main offices and field operations. Staff are expected to perform numerous deployments, over the next 4 years period. Operational deployments are performed to environments considered hazardous or with higher risk ratings, including EU Member States and Third Countries.

The purpose of the services is to improve EASO staff working conditions on matters such as safety and security as well as to achieve a safer work environment by providing standardization of predeployment procedures and more holistically mission organization approach.

A detailed list of the requested trainings and consultancy shall be provided in the tender documents of this procedure.

## II. Description of the contract

III. EASO envisages awarding a Framework Service contract divided into two lots, Lot 1 (Security Trainings) and Lot 2 (Security Consultancy), with the economic operator fulfilling the exclusion, selection and award criteria of this procurement procedure. The duration of the contract will be for a period of twelve months and may be automatically renewed three times for twelve months each (maximum duration 48 months). The estimated total value for the whole framework contract duration is € 96,600.00 for the lot 1 and € 40,000.00 for lot 2.

## IV. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators trough which EASO may award the above-mentioned contract.<sup>1</sup>
