EASO/2021/865 – Negotiated Procedure for the Procurement of First Aid, Basic Life Support and Trauma supplies for EASO HQ and Operations Offices

EX ANTE PUBLICITY

I. Description of the supplies

The European Asylum Support Office (EASO) is planning to purchase of **first aid, basic life support and trauma supplies, including maintenance for basic life support assets**, with the aim to provide security and safety as emergency response capabilities to EASO staff in EASO main offices and field operations as well as to improve EASO staff working conditions on emergency procedures and reaction protocols, in line with EASO Duty of Care.

The requested supplies will include:

- **First aid supplies** such as Office Occupational First Aid Kit, Field operations Occupational first aid kit, etc.
- **Basic life support supplies** such as Office AED, AED pads, PAD electrodes, etc.
- **Trauma supplies and associated gear** such as First responder back pack, Improvised first aid, pressure bandage, etc.
- **Provision of maintenance services for BLS equipment (AEDs)**

Detailed list of the requested supplies (items) shall be provided in the tender documents of this procedure.

II. Description of the contract

EASO envisages awarding a single framework contract. The maximum estimated duration of the contract will be **48 months**. The estimated total value for the whole framework contract duration is **€125.000,00 EUR**.

III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators through which EASO may award the above-mentioned contract.¹

This ex-ante publicity has an indicative value and is in no way binding on EASO. EASO may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.
