Framework Contract for the Provision of Maintenance services and supplies of materials

I. Description of the services

The European Union Agency for Asylum (the EUAA) is planning to purchase a service for the provision of maintenance services and supplies of materials/spare parts for the EUAA premises located in Rome. More in detail, the requested services will include:

- Hydraulic system (faucet leaks, running toilet, periodical check for leaks);
- Electrical system (Light fixtures change of office lights, light bulbs replacement);
- Network system (sockets, patching -cable routing);
- Air-conditioning and heating systems;
- Moving and / or installation of Videoconferencing devices with installation of wiring and cable covers;
- Porterage and removal, including the installation (assembly and disassembly) of any furniture where necessary (desks, wardrobes, drawers, wall-mounted blackboards, vertical drop-down curtains, paintings, chairs and kitchen furniture) and subsequent removal of bulky materials/waste;
- Supply and installation of roller blinds;
- Painting;
- Indoor division of rooms with wooden walls/panels.

II. Description of the contract

The EUAA envisages awarding a service framework contract. The maximum estimated duration of the contract will be 48 months. The estimated total value for the whole framework contract duration is € 51,000 EUR.

III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 3 economic operators through which the EUAA may award the above-mentioned contract.1 This ex-ante publicity has an indicative value and is in no way binding on the EUAA. The EUAA may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.
