Ex-ante publicity

Negotiated procurement procedure for the "Provision of OSINT (Open-source intelligence) Reports on Migration that fulfil the specific requirements of the EUAA Data Analysis and Research Sector and its stakeholders."

I. Description of the service

The European Union Agency for Asylum (the EUAA) is planning to obtain regular and high-quality OSINT (Open-source intelligence) Reports on Migration that fulfil the specific requirements of the EUAA Data Analysis and Research Sector and its stakeholders.

More in detail, for this contract, the EUAA envisages three different types of deliverables:

Deliverable 1: Short Reports. The short reports shall be between 1,200 and 1,600 words-long and are to be written and delivered in 2 working days. These reports will integrate information from the sources mentioned in the checklist into a short analysis of selected topics.

Deliverable 2: Medium Reports. The medium reports shall be between 3,000 and 4,000 words-long and are to be written and delivered in 5 working days. These reports will integrate information from sources mentioned in the checklist into a more detailed analysis of selected topics.

Deliverable 3: Long Reports. The long reports will be between 6,000 and 8,000 words-long and are to be written and delivered in 10 working days. These reports will integrate information from sources mentioned in the checklist into an in-depth analysis of selected topics.


The structure of the reports will depend on the selection of topics to be analyzed in each report.

Description of the contract

The EUAA envisages awarding a **service framework contract**. The **maximum** estimated duration of the contract will be **36 months**. The contract will be concluded for 24 months with a possible extension of maximum 12 months.

The estimated total value for the whole framework contract duration is € 120.000.

II. Description of the procurement procedure





This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators through which the EUAA may award the above-mentioned contract.¹

This ex-ante publicity has an indicative value and is in no way binding on the EUAA. The EUAA may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.
