**SUBJECT: EASO/2019/752 – Negotiated Procedure for the Procurement of plastering, painting, soffits and partitioning works for EASO’s premises in Malta**

## **EX ANTE PUBLICITY**

### **I. Description of the works**

The European Asylum Support Office (EASO) is planning to procure plastering, painting, soffits and partitioning works for its premises in Malta.

More in detail, the requested works will include:

#### **Plastering, painting, soffits works:**

- Mineral Fibre Soffit Supply, deliver, hoist and assemble in place on site, including any necessary fixtures, service holes and cutting and trimming;
- Minor making good of walls to include for filling of any chasing, holes in walls and removal of fixings in order to prepare wall to take plaster finish;
- Painting of internal walls including filling of any chasing, holes in walls and removal of fixings in order to prepare wall to take painting finish;
- Replace damaged existing soffit tiles including cutting as required to fit in existing structure.

#### **Partitioning Works:**

- Supply and Construct of wall linings;
- Supply and construction of partitions.

### **II. Description of the contract**

EASO envisages awarding a single framework contract for works with the economic operator fulfilling the exclusion, selection and award criteria of this procurement procedure. The duration of the contract will be for a period of twelve months and will be automatically renewable three times for twelve months each (maximum duration 48 months). The estimated maximum amount for this contract is €1,000,000.

### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators through which EASO may award the above-mentioned contract.<sup>1</sup>

This publication has an indicative value and constitutes no obligation to award a contract for EASO nor to invite to tender for low value contracts procedures any economic operator having expressed its interest in participating.

Only the tenderers invited by the contracting authority to participate in a procedure for awarding low value contracts will be admissible.
