

Analysis on Asylum and Temporary Protection in the EU+ in the Context of the Ukraine Crisis Week 31 (1 – 7 August) 2022

10 August 2022

Background

To ensure a timely situational picture after the Russian invasion in Ukraine, the EUAA has been monitoring the situation of asylum and temporary protection based on data exchanged within the Early warning and Preparedness System (EPS) with EU+ countries. These data are provisional, unvalidated data and therefore might differ from validated data submitted at a later date to Eurostat (according to Regulation (EU) 2020/851 amending Regulation (EC) 862/2007). The numbers included in this report might be subject to retroactive revisions.

Just over 4 million registrations for temporary protection²

According to UNHCR data, from the start of the invasion on 24 February to 8 August 2022 some 10.6 million exits from Ukraine have occurred, among which close to 7.9 million were entries from Ukraine to the four EU neighbouring countries.³ Just over 4 million persons fleeing Ukraine have registered for temporary protection in the 29 EU+ countries from the beginning of the war to 7 August 2022.⁴ There have also been some 4.4 million entries to Ukraine from abroad⁵ from the start of the war until 8 August, which includes also back-and-forth movements.⁶ From 21 February to 7 August 2022, some 24 000 applications for international protection were lodged by Ukrainian nationals. Within Ukraine, about 6.6 million persons were internally displaced, according to IOM estimates as of 23 July,⁷ up from 6.3 million a month earlier⁸ and indicating the first increase since May.

Around 48 500 registrations for temporary protection of Ukrainians vs just about 220 asylum applications in the EU+




Figure 1: Asylum applications and registrations of temporary protection for Ukrainians, week 31 2022 (Source: EUAA EPS)

In week 31, Ukrainians lodged 223 applications for international protection in the EU+ (Fig. 1). At the same time, at least 51 203 persons registered for temporary protection in 29 reporting countries,⁹ of whom the vast majority (48 512) were Ukrainians (Fig. 1).¹⁰

The Council of the adopted an implementing decision activating temporary protection directive (TPD 2001/55/EC) on 4 March.11 Since then, EU+ countries have been adopting the necessary national legislation to ensure adequate implementation,¹² configuring electronic systems and gradually reporting to the EUAA. Registrations included in this analysis cover both those conducted under the TPD and similar provisions under national law.

Nearly all registered for temporary protection were Ukrainian nationals

The Council decision envisages temporary protection for Ukrainian nationals residing in Ukraine before 24 February 2022 as well as some categories of nationals of other third countries and stateless persons who were previously residing in Ukraine.

In week 31, at least 95 % of those registered for temporary protection were Ukrainian nationals (but for some 3 % the citizenship could not be reported). Among other registered nationalities, the most prominent were Moroccans (322) and Russians (125).

Some 58 % of the registered persons were female but for about 4 % the sex was not reported.

Second-lowest level of Ukrainian asylum applications since the Russian invasion




Figure 2: Weekly Ukrainian asylum applications in the EU+, week 1-31 2022 (Source: EUAA EPS)

In week 31, Ukrainians lodged 223 asylum applications in EU+ countries (Fig. 2). Except for week 25 (210 applications), this was the lowest level since the Russian invasion began but still substantially higher than immediately prior to the invasion. In week 31, Ukraine was only 20th in the list of top countries of origin of asylum applicants in the EU+. Nevertheless, Ukraine remained the fourth top country of origin of asylum applicants so far in 2022.
