## Location:

<u>Registrations:</u> The Training National Contact Points should send the registration form to: **training-ncp@euaa.europa.eu** as soon as possible, and no later than the dates indicated above. The registration for is available on EUAA Learning Management System.

<u>Costs:</u> There are no fees for the training, but participants must cover their own costs for travel and accommodation regarding the face-to-face session, if applicable.

<u>Assessment</u>: Some of the EUAA modules offer assessments at the end. These assessments aim to ensure that learning outcomes have been met. Registering for assessments in **Learners' Curriculum sessions** is a voluntary process.
