


Consolidated Annual Activity Report 2022

Highlights

The year in brief

In 2022 Europe faced the largest humanitarian crisis since the Second World War.

A month after Russia's invasion of Ukraine, the Council activated the <u>temporary</u> <u>protection directive</u>, enabling Member States to provide quick and effective protection to people fleeing the war.





Against this background, total asylum **applications** as well as those filed by **non-accompanied minors** were the highest since the crisis in 2015-2016.

So was the ratio of applications to decisions.










Key achievements

In response to the crisis, the Agency extended its technical and operational support to six new Member States.

The number of operational plans being implemented (14) reached an unprecedented high.

At the Commission's request, the Agency also deployed staff to a non-EU country (Moldova) to support Member States with voluntary transfer of persons fleeing the war in Ukraine to Europe.



In cases of disproportionate pressure on national asylum and reception systems, the Agency is now able to draw on a pool of national experts, presently over 300 strong.

Over 1000 of its own personnel had been deployed over the course of the year.

The Agency effectively addressed a growing need for capacity building and training.


Participations in **training** organized grew by 72%. An expanding **European Asylum Curriculum** promoted asylum and reception standards and best practice.

A record number of members of courts and tribunals participated in the EUAA's judicial support activities.
The judicial experts' pool grew by a third.

The Agency continued to build capacity of partner countries outside the EU and to facilitate Member States' cooperation and exchange in relation to these 'third countries'.

Asylum and reception knowledge was further enhanced.

Production of **situational analyses** was increased.

Operational standards, indicators, guidelines, best practice were drafted and promoted.

Close to 3 000 pages of country-of-origin-information were created.

Over 1 000 individual medical requests were addressed and made available to targeted users.

New and/or updated country guidance on Somalia, Afghanistan and Iraq was published.



Governance

On 19 January 2022, the EUAA regulation entered into force.




To deliver on its <u>enhanced mandate</u>, the Agency reorganised and managed the roll out of new tasks and functions via a dedicated transition programme.

The <u>EUAA Consultative Forum</u> was reconstituted with an enhanced role, envisaged by the new regulation.


The revised objectives of the Annual Work Programme were for the most part fully or nearly achieved.

Budget implementation (EUR 168.8M) was above set targets.

All 17 internal control principles are assessed as effective or fully effective, with moderate or minor deficiencies of internal controls requiring some improvement. Fourteen evaluations were concluded, the highest number in the last eight years.
