Introduction

This summary presents legislative, institutional and policy developments in asylum and reception in EU+ countries in 2023, as presented in the Asylum Report 2024. Details for each development and further analysis are provided in the report.

•	Belgium	The Dublin procedure	The Council of Ministers approved a reform package on the migration model. It would codify in national law that the Immigration Office can extend the timeline for a Dublin transfer from 6 to 12 months when the applicant is detained in a penal institution, and to 18 months when the person has absconded.
	Belgium	Special procedures to assess protection needs	Georgia was removed from the list of safe countries of origin.
•	Belgium	Reception of applicants for international protection	The Council of Ministers approved a royal decree which obliges applicants who work to contribute to reception costs. In addition, applicants who are in a stable and sustainable professional situation with high salaries can be asked to leave the reception network.
•	Belgium	Reception of applicants for international protection	The Council of Ministers approved the draft law to amend the law on the reception of asylum seekers. The right to material assistance will end with a final negative decision in the international protection procedure.
•	Belgium	Detention during the asylum procedure	The draft of the new Migration Code makes clear that children cannot be held in closed centres.
	Belgium	Interpretation services	Amendments to laws were prepared on the recruitment and status of interpreters.
•	Belgium	Statelessness in the context of asylum	The Council of Ministers approved a draft legislation which would become law in early 2024, setting up a specific procedure and a specific legal right to stay for stateless people, provided they have involuntarily lost their nationality, cannot obtain or retrieve one, and prove they cannot receive a residence permit in any another country.
•	Belgium	Content of protection	The Flemish region of Belgium introduced an obligatory, standardised Dutch language test for newcomers, including beneficiaries of international protection, as part of civic integration courses.
•	Belgium	Unaccompanied minors and vulnerable groups	The Council of Ministers approved the creation of a separate residence right for parents when their children qualify for international protection but they themselves do not.
	Bulgaria	Processing asylum applications at first instance	The authorities adopted a circular for the implementation of the accelerated procedure, pending the amendment of the Law on Asylum and Refugees.



-	Bulgaria	Processing asylum applications at first instance	Legislation is being amended to enable a negative decision on international protection and a return decision to be issued jointly.
_	Bulgaria	Interpretation services	National legislation on asylum was amended to allow EUAA interpreters to support the registration and assessment of applications for international protection.
*	Croatia	Reception of applicants for international protection	Amendments to the Law on International and Temporary Protection clarified that a recognised beneficiary of international protection may stay in the reception centre for 60 days following a positive decision. Within 8 days, they may request accommodation from the competent regional office or they need to find suitable accommodation on the private market.
*	Croatia	Reception of applicants for international protection	The Law on International and Temporary Protection was amended to reduce the waiting period to access the labour market for applicants for international protection from 6 to 3 months. Applicants need to request a work permit, which is delivered within 1 month, and if they conclude a work contract, they must inform the reception facility within 15 days. Once the applicant status ceases, the work permit must be returned within 15 days.
*	Croatia	Reception of applicants for international protection	The Law on International and Temporary Protection was amended to extend applicants' access to medical care beyond emergency situations, upon a doctor's recommendation.
	Croatia	Detention during the asylum procedure	The Law on International and Temporary Protection was amended to introduce new grounds for applying restrictions on the movement of applicants, including multiple consecutive attempts to leave the country during an asylum procedure. The decision on the restriction is regularly reviewed by the administrative court if it lasts longer than 1 month and if there is a change in circumstances that may affect the legality of the decision. The court also reviews the decision upon request by the applicant.
	Croatia	Legal assistance and representation	The Law on International and Temporary Protection was amended to introduce two new obligations related to visits and communication of the detained asylum seekers with legal advisers, UNHCR, family members and the right to orally receive information on legal aid in a language the applicant can understand, when such information cannot be provided in writing.





	Croatia	Unaccompanied minors and vulnerable groups	Amendments to the Law on International and Temporary Protection specified that the guardian is obliged to start family tracing as soon as possible for an unaccompanied child. In addition, confidentiality must be respected when managing information on a child and the family in order not to jeopardise the child's safety
*	Croatia	Unaccompanied minors and vulnerable groups	Amendments to the Law on International and Temporary Protection clarified that children in reception must be offered appropriate recreational activities, including outdoor activities.
	Cyprus	Processing asylum applications at first instance	The Ministry of the Interior published a draft bill proposing to establish a Deputy Ministry of Migration and Asylum. This would result in one institutions being responsible for creating and implementing an integrated strategy for migration and asylum.
	Cyprus	Unaccompanied minors and vulnerable groups	The law was amended to state that asylum seekers who do not consent to the medical examination for an age assessment are presumed to be adults. However, they can submit additional information at any stage of the process to establish their minority and can request the medical examination at a later stage, which cannot be disregarded by the Asylum Service.
S	Cyprus	Unaccompanied minors and vulnerable groups	A bill proposal on guardianship and fostering children was approved by the Council of Ministers to enhance protection and support for children in the care of the Social Welfare Services.
	Czechia	Access to procedure	After the amendment to the Act on Asylum, through Act No 173/2023, it is no longer possible for third-country nationals to apply for international protection in hospitals.
	Czechia	Special procedures to assess protection needs	Legislative amendments transferred the responsibility from the municipal court to the Regional Court in Prague for appeals against decisions on applications made in the transit area of the international airport.
	Czechia	Special procedures to assess protection needs	Legislative amendments established the possibility for applicants who made an asylum application at the transit area of the international airport to file a cassation complaint with the Supreme Administrative Court is the appeal is rejected by a court of first instance.
	Czechia	Special procedures to assess protection needs	Armenia and the United Kingdom were added to the list of safe countries of origin, while Ukraine was removed. Exceptions were removed for Georgia and Moldova.

Czechia	Processing asylum applications at first instance	New legislation entered into force in July 2023 aiming to streamline the asylum procedure before administrative authorities and administrative courts.
Czechia	Processing asylum applications at second or higher instance	Act No 173/2023 amended the Asylum Act to provide a detailed overview of time limits to lodge an appeal.
Czechia	Processing asylum applications at second or higher instance	An amendment introduced by Act No 173/2023 provides that, when assessing an appeal, the court must also consider new, important facts that have arisen after the administrative decision, if they relate to possible persecution or the threat of serious harm. The court must cancel the administrative decision and return the case to the administrative body for further proceedings if the facts have an effect on the administrative body's decision on the merits.
Czechia	Reception of applicants for international protection	An amendment introduced by Act No 173/2023 allows for an employee designated by the reception facility operator to prevent an applicant from entering or remove them from the facility if the applicant is under the influence of alcohol or other addictive substances, or if the person is a threat to him/herself or to others, to the property, public order or had already caused harm.
Czechia	Detention during the asylum procedure	Act No 173/2023 introduced changes to the timelines in detention.
Czechia	Statelessness in the context of asylum	An amendment of the Act on the Residence of Foreigners went into effect in July 2023. It provides a definition of a stateless person and includes relevant provisions concerning recognition, relevant procedures and the content of protection for stateless persons.
Czechia	Content of protection	According to an amendment of the Act on the Residence of Foreign Nationals, third-country nationals whose application for international protection was rejected can no longer acquire a permanent residence permit by having lived in the country for 4 years.
Czechia	Content of protection	An Amendment of the Act on Asylum clarified what type of travel document are issued to beneficiaries of protection, according to their status.
Czechia	Content of protection	An amendment of the Act on the Residence of Foreign Nationals introduced reductions in administrative fees for procedures related to the issuance of a residence permit and replacing a damaged, lost or stolen card.
Denmark	Special procedures to assess protection needs	The Russian Federation was removed from the list of safe countries of origin.





==	Denmark	Content of protection	The Special Act for Persons having Assisted Danish Authorities in Afghanistan was extended until 30 November 2025. The act was adopted in 2021 and initially granted a 2-year residence permit for Afghans who qualified.
==	Denmark	Content of protection	A new law makes it mandatory for people who receive social support benefits to participate in internships and employment programmes for 37 hours a week.
#	Finland	Processing asylum applications at first instance	The new government presented a proposal to introduce a border procedure.
-	Finland	Detention during the asylum procedure	The Ministry of the Interior worked on amendments to the grounds for immigration detention to include public order, security and the commission of serious crimes. The proposal also extends the length of detention from 6 to 12 months.
#	Finland	Content of protection	The Ministry of the Interior published a draft bill proposing to limit residence permits to 3 years based on refugee status and to 1 year for a permit based on subsidiary protection, with extended permits limited to 2 years. The bill also proposes withdrawing a person's international protection status and their residence permit based on that status if the person commits a serious offence in Finland that endangers public order and security or if the person endangers national security.
"	France	Access to procedure	A new asylum and immigration law was debated, with several proposals suggesting changes and adjustments for a more efficient registration process. The law was promulgated at the beginning of 2024.
=	Germany	Special procedures to assess protection needs	Georgia and Moldova were added to the list of safe countries of origin.
	Germany	Reception of applicants for international protection	All applicants can have access to the BAMF language programme, regardless of their prospects for being recognised.
_	Germany	Unaccompanied minors and vulnerable groups	Providers of counselling sessions can transmit the personal data of an applicant to the authorities if it arises during the discussion that the person is in need of special procedural guarantees or has special needs in reception, provided the applicant consents to this transfer of information.
	Germany	Unaccompanied minors and vulnerable groups	The reform of the Guardianship and Care Law came into effect.



≝	Greece	Legal assistance and representation	The government adopted a decision which defines practical aspects of the Asylum Code, in particular access to free legal aid in the appeals procedure, the functioning of the Registry of Lawyers, lawyers' tasks, obligations and payment.
=	Hungary	Access to procedure	The embassy procedure continued to be implemented, despite the CJEU ruling considering the legislation in breach of EU law.
#	Iceland	Special procedures to assess protection needs	The Aliens Act was amended to provide clearer definitions of what constitutes delays in case processing attributable to applicants.
#	Iceland	Special procedures to assess protection needs	According to amendments to the Aliens Act, the decision to reject an asylum application as inadmissible is now automatically appealed to the Immigration Appeals Board (in Dublin-cases, cases when the applicant already received international protection in another country or has a connection to another country (safe third country) that it can be considered reasonable that they stay there), unless the applicant specifically expresses the intention not to appeal the decision.
#	Iceland	Special procedures to assess protection needs	Subsequent applications can now be dismissed, unless new information is available that increases the applicant's probability of being recognised as a beneficiary of international protection.
#=	Iceland	Processing asylum applications at second or higher instance	Appeals on the rejection of a subsequent application are decided by the Chairperson or Vice-Chairperson of the Appeals Board instead of a panel of committee members.
#	Iceland	Reception of applicants for international protection	Amendments to the law specified that applicants with a final rejection retain their reception rights for a maximum 30 days after the administrative decision becomes final. Several exemptions exist to this rule. In addition, the police may authorise to postpone the termination of the rights in certain cases.
#=	Iceland	Unaccompanied minors and vulnerable groups	The Icelandic Law on Foreigners now specifies that authorities are obliged to take into account the minority of an applicant in the assessment of an application for international protection if the child turned 18 after arriving in the country.
##	Iceland	Unaccompanied minors and vulnerable groups	Legislative amendments require the minister in Iceland to establish a regulation on the assessment of the interests of a child who have applied for international protection, but a residence permit on humanitarian consideration may still be granted.





	Ireland	Processing asylum applications at first instance	A number of acts in the statute relating to immigration, including legislation on international protection, were amended in 2023 to allow for electronic immigration notices. Previously, immigration notices were generally only possible through the postal service. These amendments support efforts to modernise Ireland's immigration system.
	Ireland	Processing asylum applications at second or higher instance	The term of office of a member appointed in a whole-time capacity on the tribunal was amended from 3 to 5 years.
	Italy	Access to procedure	Italy and Albania concluded a protocol on strengthening cooperation in migration matters.
"	Italy	Access to procedure	The penalty for human trafficking was increased and a new crime of "death or injury as a consequence of crimes in the field of illegal immigration" was introduced.
	Italy	Access to procedure	A state of emergency was introduced due to the increased number of arrivals.
"	Italy	Special procedures to assess protection needs	Law No 50/2023 allows for the accelerated processing of applications at the border or transit zones for applicants coming from safe third countries or who attempted to evade border checks. These applicants may also be detained at the border. The authorities must decide on their application within 7 days.
•	Italy	Special procedures to assess protection needs	Côte d'Ivoire, Georgia, Nigeria and The Gambia were added to the list of safe third countries by Decree of 17 March 2023.
•	Italy	Special procedures to assess protection needs	Amendments specified that a subsequent application may only be considered admissible if external circumstances prevented the applicant from submitting new elements earlier. The applicant must explain and prove the reasons for the delay. The suspensive effect of an appeal is no longer automatic when a first subsequent application has been considered as inadmissible or a negative decision was issued on the merits.
•••	Italy	Processing asylum applications at first instance	Law No 50/2003 introduced the possibility to address staff shortages in the determining authority by using officers of the local prefecture. The law requires new staff to be adequately trained.
•••	Italy	Processing asylum applications at second or higher instance	Law No 50/2023 provided that, before filing an appeal, lawyers may access the video recording of the applicant's hearing before the Territorial Commission.
•••	Italy	Processing asylum applications at second or higher instance	Law No 50/2023 provided that for appeals registered before 31 December 2021 and still pending, a motion may be presented by the lawyer to prioritise the assessment of the right

•	Italy	Reception of applicants for international protection	Law No 50/2023 allows for the derogation of certain laws to facilitate the opening and operating of hotspots and government reception centres. It also allows the Italian Red Cross to manage the Lampedusa hotspot.
••	Italy	Reception of applicants for international protection	Law No 50/2023 foresees that, to alleviate pressure on hotspots, foreigners can be transferred to similar facilities on the national territory to undergo identification and registration. When government reception centres are full, the prefect may identify temporary reception facilities.
	Italy	Reception of applicants for international protection	Legislative amendments underlined that applicants do not have access to second-line reception (SAI), with the exception of resettled applicants, displaced persons from Ukraine and Afghanistan, and applicants with vulnerabilities. All female applicants are considered to be vulnerable and thus have access to SAI.
"	Italy	Detention during the asylum procedure	Law No 50/2023 established that new return and repatriation centres (CPRs) may be established and maintained with a derogation from some laws (e.g. procurement) until 31 December 2025 to ensure that centres can be opened quickly.
	Italy	Detention during the asylum procedure	According to Law No 50/2023, applicants may be detained to determine elements on which the asylum claim is based and which cannot be established without detention, within the limits of places in CPRs.
•	Italy	Detention during the asylum procedure	Law No 50/2023 extended the circumstances for a risk of absconding to include when the applicant does not have a passport or when the applicant provides a false identity.
	Italy	Detention during the asylum procedure	According to Law No 50/2023, applicants may be detained in hotspots or CPRs when lodging an application at the border to assess their right to enter the country if they arrive from a safe country of origin or by evading relevant border checks.
	Italy	Detention during the asylum procedure	According to Law No 50/2023, applicants can provide a financial guarantee as an alternative to detention.
•••	Italy	Detention during the asylum procedure	For applicants awaiting a Dublin transfer, Law No 50/2023 allows their detention in CPRs if there is a significant risk of absconding, but only for the time strictly necessary for the execution of the transfer and for a maximum of 6 weeks.





	Italy	Content of protection	The criteria for national forms of protection was revised. The wording of the ECHR, Article 8 was cancelled. This national (special) protection may be granted on the basis of international or constitutional obligations.
	Italy	Content of protection	Amendments specified that a short-term return to the country of origin is enough for the cessation of international protection status, unless the travel takes place for serious and proven reasons for strictly the necessary period. An additional ground for withdrawing international protection was added, when the beneficiary for international protection submits an application for another type of permit.
••	Italy	Unaccompanied minors and vulnerable groups	Unaccompanied minors turning 18 are now issued a residence permit with a maximum duration of 1 year.
••	Italy	Unaccompanied minors and vulnerable groups	A new legislative decree allows the public security authority to order anthropometric tests or other medical examinations (such as X-rays) to identify age in the event of emergency conditions (e.g. substantial, multiple and frequent arrivals, rescues at sea, etc.). In such cases, the authority must give immediate notice to the Public Prosecutor's Office at the Tribunal for Minors, which authorises the execution in writing or, in cases of particular urgency, orally and subsequently confirmed in writing. The law has also foresees a detailed procedure for drafting the reports for examinations and appeal mechanisms.
••	Italy	Unaccompanied minors and vulnerable groups	The ordinary age assessment procedure was amended, providing that the age assessment must be carried out by a multidisciplinary and multi-professional team of experts (composed of a paediatrician, a psychologist specialised in child development or a child neuropsychiatrist, a cultural mediator and a social assistant) and completed within 60 days.
	Italy	Unaccompanied minors and vulnerable groups	Legislative amendments prescribe that unaccompanied minors are accommodated in SAI facilities, following an initial stay in a government reception facility. In the event of mass arrivals of unaccompanied children when reception cannot be provided by a municipality, the prefect must activate dedicated temporary structures for minors. When these structures are momentarily not available either, youngsters above the age of 16 may be accommodated in special sections of facilities foreseen for adults for a maximum of 90 days.



=	Latvia	Access to procedure	A new law provides the Cabinet of Ministers with the authority to declare a situation of emergency when it considers that there is a disproportionately high number of cases of illegal or attempted crossings of the state border.
=	Latvia	Processing asylum applications at second or higher instance	A new local court was afforded the competence to receive asylum appeals.
-	Lithuania	Access to procedure	The Lithuanian parliament adopted amendments which allow border guards to return migrants who cross into Lithuania irregularly during a state of emergency.
_	Lithuania	Reception of applicants for international protection	Draft amendments were approved by the government to establish an agency on the basis of the Refugee Reception Centre which will be in charge of the reception of and support for applicants, an entity under the Ministry of Social Security and Labour.
-	Lithuania	Reception of applicants for international protection	A legislative amendment stipulates that the decision for an applicant's accommodation must be made by the Migration Department. Applicants must be accommodated without their freedom of movement restricted, if certain conditions are met. When assessing restrictions on the freedom of movement, the authorities must also assess the applicant's age, health, family situation and other relevant circumstances.
-	Lithuania	Reception of applicants for international protection	A legislative amendment established that the process to appeal the decision on accommodation must be done within 14 days before the district court.
-	Lithuania	Detention during the asylum procedure	Amendments revising detention provisions came into force in Lithuania at the end of 2023, including a new alternative to detention which allows a person to leave the assigned accommodation only with the permission of the head of facility.
-	Lithuania	Legal assistance and representation	Following legislative amendments, the Ministry of Social Security and Labour, or an institution authorised by it, will replace the Migration Department in the organisation of stateguaranteed legal aid for third-country nationals.
=	Luxembourg	The Dublin procedure	The Law on International and Temporary Protection was amended to include a list of circumstances when there is aa significant risk for absconding and when to detain an applicant.
	Luxembourg	Reception of applicants for international protection	Changes made to accessing material reception conditions established that applicants must first lodge an application at the General Department of immigration before they can request accommodation.





	Luxembourg	Reception of applicants for international protection	Legislative amendments clarified the amount of food and hygiene products to be received and defined the same amount of basic assistance for all applicants, regardless of age. Material reception conditions may also be given in cash.
	Luxembourg	Reception of applicants for international protection	Labour market tests were abolished to facilitate access to employment.
	Luxembourg	Content of protection	A new law on intercultural living entered into force in January 2024.
=	Netherlands	Reception of applicants for international protection	The new Distribution Act was adopted in January 2024. It aims to proportionally divide the responsibility for reception places among municipalities.
=	Netherlands	Statelessness in the context of asylum	In June 2023, the Dutch Parliament passed a legislative package pertaining to statelessness. The Statelessness Determination Procedure Act established a new procedure and an amendment to the Dutch Nationality Act provides stateless children born in the Netherlands with a pathway to Dutch nationality.
•	Portugal	Statelessness in the context of asylum	Parliament passed a law in August 2023 that defines a stateless person and recognises that people who meet the criteria of the 1954 Convention are entitled to both stateless status and a travel document.
•	Romania	Processing asylum applications at first instance	Emergency Ordinance No 35/2023 was approved to provide that the General Inspectorate for Immigration will issue a negative decision on international protection jointly with a return decision. The legislation also provides a third-country national's right to remain in Romania until the asylum procedure is completed and for 15 days after the procedure is finalised, and clarifies that applicants benefit from their rights until the procedure is finalised.
•	Romania	Processing asylum applications at first instance	Emergency Ordinance No 35/2023 was approved to provide for the participation of EUAA experts in the registration and assessment of asylum applications.
•	Slovakia	Processing asylum applications at second or higher instance	Changes to the court system came into effect in June 2023. Three new administrative courts were created in Bratislava, Banská Bystrica and Košice. Two of them – the administrative courts in Bratislava and Košice – have jurisdiction over administrative actions in asylum, detention and administrative expulsion matters. The Supreme Administrative Court is competent to decide on cassation against rulings of these specialised administrative courts.



	Slovenia	Reception of applicants for international protection	Amendments to the Act Amending the Employment, Self-Employment and Work of Foreigners Act enables asylum seekers the right to access the labour market after 3 months.
-	Slovenia	Reception of applicants for international protection	A decree providing appropriate accommodation, care and treatment for unaccompanied minors was adopted in October 2023, which established a dedicated reception facility and accommodation centre. The decree became operational in April 2024.
-	Slovenia	Statelessness in the context of asylum	The government announced accession to the 1961 Convention on the Reduction of Statelessness.
*	Spain	Reception of applicants for international protection	A new regulation was adopted on sanctions for breaching the house rules in reception facilities.
-	Sweden	Processing asylum applications at first instance	The Swedish Migration Agency suspended enforcement to Sudan.
+-	Sweden	Country of origin information	A new legal position was published on the protection needs of nationals from Yemen.
==	Sweden	Statelessness in the context of asylum	A new legal position was published on statelessness.
-	Sweden	Content of protection	The Swedish Migration Agency updated its legal position and clarified that the need for a new personal interview before the decision on revocation must be decided individually.
•	Switzerland	Processing asylum applications at second or higher instance	The Federal Council repealed the COVID-19 ordinance on 15 December 2023, thus for accelerated procedures the expanded appeal time limit resumed from 30 days to 7 working days and for interim rulings from 10 to 5 working days.

Operators of collective reception facilities and hosts of private accommodation received increased reimbursements per person.

=	Austria	Country of origin information	The Country of Origin Information—Content Management System (COI-CMS) now offers the possibility to mechanically translate COI reports into 24 different languages through DeepL.
