


## Methodology

The methodology applied to the EUAA Asylum Report is followed in the Who is Who project. Accordingly, the Information and Analysis Sector undertakes desk research based on publicly-available sources and EUAA reports. The information was validated by Member States, for the exception of Croatia, Estonia, France and Italy.





# Overview of authorities involved in access to the asylum procedure

According to the recast Asylum Procedures Directive ([recast APD](#)), any third-country national or stateless person who expresses the wish to apply for international protection should be registered as soon as possible by a Member State as an applicant for international protection.

Article 6 of the recast APD sets out the legal standards which ensure access to the asylum procedure on the basis of a three-step approach consisting of the making, registering and lodging of an application.

Article 8 of the recast APD states that Member States must provide information to a third-country national or stateless person who is held in detention or present at a border crossing, including transit zones, if they express the wish to make an application for international protection.

Depending on the structure of the national authority, the registration and the lodging of an application may be conducted concurrently or separately. When these two steps are conducted separately, basic background data are collected at the registration stage, which allows for the practical organisation of initial reception. Additional detailed data are gathered during the lodging stage.

The Who is Who in International Protection in the EU+: Authorities Involved in Access to the Asylum Procedure<sup>1</sup> platform and report present information on the authorities that are involved in the three steps involving access to protection:

- **Making an application:** Reference is made to authorities which are likely to receive an application for international protection according to the recast APD, Article 6(1).
- **Registering an application:** Reference is made to authorities which are competent under national law for registering an application for international protection according to the recast APD, Article 6(1.1).
- **Lodging an application:** Reference is made to authorities which are competent for the lodging of an application for international protection according to the recast APD, Article 6(2-4).

For countries not bound by the recast APD, namely Denmark,<sup>2</sup> Ireland,<sup>3</sup> Iceland, Norway and Switzerland,<sup>4</sup> a similar national legal framework applies. References to these countries should be read in relation to the applicable national legal framework.

This overview supplements the mapping of the [Asylum Authorities in the EU+](#) which are responsible for the examination of an application for international protection in each EU+ country.

## Key findings

- ✓ In 23 EU+ countries, the authorities in charge of the registration and the lodging of an asylum application are the same. In France and Iceland, different authorities are engaged in these steps of the procedure. In five countries, additional authorities are involved in registration (in Croatia, Denmark, Germany and Slovenia) or lodging (in Belgium).
- ✓ The lodging of an application overlaps with registration in six EU+ countries (namely Finland, Ireland, Netherlands, Poland, Romania and Sweden).
- ✓ In Luxembourg, authorities involved in making, registering and lodging an application generally overlap. In Switzerland, the legislation does not make a distinction between making, registering and lodging an asylum application.
- ✓ In all countries, police or border authorities are likely to receive an application for international protection.
- ✓ Multiple national authorities may be engaged in the making of an application. Differentiations are encountered for applications made at the border, on the territory and in detention.

<sup>3</sup> Pursuant to Protocol No 21 on the position of the United Kingdom and Ireland in respect of the Area of Freedom, Security and Justice, annexed to the Treaty on European Union (TEU) and the TFEU, and without prejudice to Article 4 of that Protocol, Ireland is not taking part in the adoption of the recast APD and is not bound by it or subject to its application. 
