<u>Registrations:</u> The Training National Contact Points should send the registration form to: **training-ncp@euaa.europa.eu** no later than the registration deadline. The registration form is available on EUAA Learning Management System.

<u>Language</u>: The language of training is English.

<u>Costs:</u> There are no fees for the training, but participants must cover their own costs for travel and accommodation regarding the face-to-face session, if applicable. Should this provision be subject to changes in the course of 2025, Training National Contact Points shall be timely informed.

<u>Assessment</u>: Some of the EUAA modules offer assessments at the end. These assessments aim to ensure that learning outcomes have been met. Registering for assessments in **Learners' Curriculum sessions** is a voluntary process.

Participants who register for assessments, but decide to withdraw for whatever reason, may do so, provided that the Training NCP informs EUAA at least 8 working days before the planned assessment date.

Withdrawal after the 8-day deadline will be considered a 'no show', as will failure to attend the assessment on the day, or failure to comply with the necessary steps communicated by the Remote Invigilation Service Provider.
